New Business

- <u>NC Innovation</u> Visit Christine Hendren
 - NC State Budget passed with \$500M to contract with NC Innovation in a public/private partnership
 - This is an endowment so it can regenerate for continuous investment across the state
 - NC ranks around 20th in innovation in US
 - However, NC is 38% above average the amount of dollars we draw down from the state
 - NC Innovation visited App State campus 10/24
 - There is a need to translate research into economic development
 - Use-inspired research, translational research (focused on direct line to impact) learning how to message that way for all research
 - Impact in workforce development, employability, translating the value of research into society (not just creating something you can sell)
 - NC Innovation will be doing an asset mapping with RTI (so they can decide where to invest their money). There will be opportunities for interaction between App State and NC Innovation
 - \circ There is a regional representative for the Western side of the state, Megan W (?)
- The Office of Research has been renamed the Office of Research and Innovation (ORI) and you will start seeing the name changes on the website and communication
- Policy Interactions with URC and ORI Christine Hendren and Karen Fletcher
 - There is an opportunity for creating a shared governance process as the ORI updates their policies. Proposed process: ORI identifies a priority policy/guidance

for URC input > ORI and Office of General Counsel (OGC) work together to form an early draft (OGC may gather example policies/guidance) > Drafted policy/guidance goes to URC for discussion (up to two meetings) > Draft policy/guidance with comments/thoughts from URC goes back to OGC for approval > ORI and OGC work to incorporate input from all parities into a finalized version of the policy/guidance

- The policies that the Office of Research and Innovation have ownership of are:
 - Buyout Policy for Externally Sponsored Projects
 - Care and Use of Animals for Research Teaching or Demonstration
 - Export Controls Compliance
 - Facilities and Administrative Cost Policy
 - Human Subject Research Recruitment
 - Intellectual Property Transfer
 - Payments to Human Subjects
 - Research Misconduct
 - Review of Research Involving Human Subjects
 - Use of Recombinant DNA in Research and Teaching Laboratories
- URC members identified the policies they were most interested in or felt they had the most experience in as: Buyout Policy for Externally Sponsored Projects; Facilities and Administrative Cost Policy; Human Subject Research Recruitment; Payments to Human Subjects; Research Misconduct; Review of Research Involving Human Subjects. There was also one person interested in the Intellectual Property Transfer policy.
- Policies that App State doesn't currently have that are recommended are:
 - Artificial Intelligence. Example: <u>https://researchintegrity.asu.edu/export-controls-and-security/artificial-inte</u> <u>lligence</u>

Old Business

- Update: Strategic Plan for Research, Scholarship, and Creative Activities Christine Hendren and Gabe Casale
 - Implementation Committee designated (Chrstine Hendren, Grace Plummer, Gabe Casale, Karen Fletcher)
 - Christine is working with UComm on messaging so more information about how the plan will be implemented will go out soon
 - Communication will go out that states faculty will have the option to talk to URC reps help Implementation Committee collect information/their feedback. You don't have to be an expert on the plan. Help direct them (to the plan or feedback meetings, etc)
 - Christine will host office hours periodically for people to talk to her about the plans being implemented
 - Department meetings will be offered to go over the implementation plan and how to be engaged
 - What kinds of things would you want to know about in a department meeting? Discussion followed and the following questions were posed:
 - Who is the intended audience?
 - What are the main points of the plan?
