DISCUSSION ON COVID-19 IMPACT ON RESEARCH AND CREATIVE ACTIVITY - Ece Karatan

The <u>Continuity of Research</u>, <u>Creative</u>, and <u>Scholarly Activities website</u> has been created as a guide. All expenditure approvals are controlled by Paul Forte of Business Affairs. URC funds are flexible, but this funding can be absorbed by the state. Flexibility with the use of these funds will be granted to the extent possible.

Students are currently not working on grants. Funding is being drained by emergency leave pay to them. If possible, Office of Research will reimburse for this expense. Thus, these expenses need to be tracked. If research can be expanded and performed remotely, please submit a project modification.

The authorization to perform field work and return to labs is determined by the Chancellor. Office of Research is closely monitoring this and is establishing guidelines for field work for the Provost's review (safe distancing, safety contact if alone in the field, etc.). Multiple scenarios are covered in the return plan proposal.

Although some projects are time sensitive, please submit URC applications for review. Then, those concerns will be addressed and adjusted if necessary through scope modifications.

In Music there have been cancelled performances. Is credit still given? This is a question for the chairs to bring to Vice Provost Jacqui Bergman and Interim Provost Heather Norris.

Human Subjects research that cannot be done remotely is currently on pause. Some research projects can be converted to use online surveys.

All hires are approved by Chancellor Everts from a list provided by Provost Norris. Marie Hoepfl states that the Graduate School has blanket approval to hire graduate students who work remotely.
