New Business

- I. Data Recovery Jim Webb, Chief Information Security Officer and Deputy Chief Information Officer, App State
 - A. If you had any equipment damage or data damage (external harddrive) reach out to Jim. ITS has contracts with data recovery services (cost associated with) cost can be negotiated with these firms for you.
 - B. Safest place to store data is M (shared with colleagues) or P (personal) drive, also uStor (central on campus file service cloud backup)
 - C. If there are storage issues let ITS know.
- II. Town hall to discuss any research and creative activity related questions you may have as we move forward this semester, recovering from Hurricane Helene.
 - A. Discussion about no cost extensions for lost time first refer researchers to their grants manager. In general, the first thing to examine is when the project is supposed to end. No cost extensions aren't requested until 90-45 days before the end date of the entire project. Specific issues would be cited as reasons to report to the funding source. There are also impacts from campus closure (slow progress on some projects/awards due to these impacts).
 - 1. This is essentially the same for ORI funded internal grants (URC primarily). Folks who need internal grant extensions should fill out this form if they need additional time to complete their projects for any reason
